When Jesus spoke Truth to his accusers, he would justify himself by quoting Law. First, he would quote God's Law, and after quoting God's Law he would often quote the accuser's law and use that against them as well. For example, Jesus would say, "Did ye never read in the scriptures..." and then quote God's Law. Then he would say, "Is it not written in your law..." and quote their own law! His accusers would have no answer, they could not overcome him. How could anyone overcome somebody who is obeying both God's Law and man's law!? If a man made law is just, it will be in harmony with God's Law.

These maxims are the foundation and principles of the laws that man passes today. Unfortunately, men enforce their own will more than they enforce law. So, this is why, in addition to knowing God's Law, it is also important to know man's law, because man's law is based upon God's Law. And when you are accused of "breaking the law" you can do what Jesus did, and use both God's Law and man's law to justify your lawful acts, for this is the only thing that will excuse you.

It is important to distinguish between commercial law and maxims of law, when quoting from their law. We should never, ever quote their codes, rules, regulations, ordinances, statutes, common law, merchant law, public policies, constitutions, etc., because these are commercial in nature, and if we use their commercial law, they can presume we are engaged in commerce (which means we are of the world), which will nullify our witness (because we are not of the world). Maxims of law are not commercial law, they have withstood the test of time and, as the reader will surely notice, are mostly based upon truth, scripture and common sense.

Here is a court case which demonstrates a typical example of the fruitlessness of describing oneself in the terms of the world, as distinguished from who and what our Heavenly Father has already told us we are.

This was rendered by JOHN V. PARKER, Chief Justice:

"Petitioner's shield of the "Common Law" as an "Unenfranchised Sovereign Individual of the United States of America, a Republic," provides him with the same degree of protection from federal income taxation as did the Ghost Dance of the Sioux warrior from the repeating rifles of the federal Calvary - ZERO." 599 F.Supp. 126, *George E. McKinney, Sr. v. Donald Regan*, Secretary of the Treasury, et al., Civ. A. No. 84-470-A., United States District Court, M.D. Louisiana, November 19, 1984.

Many insist on wanting to use "common law" to defend themselves. The reason we should not is because, first and foremost, you do not see the term "common law" in the Bible. Bondservants of Christ are only to use God's Law. Secondly, the common law is a commercial law today, created by merchants, influenced by Roman Law, and used for commercial purposes.

The following definitions are taken from "*A Dictionary of Law*, by William C. Anderson, 1893."

Custom of merchants:

A system of customs, originating among merchants, and allowed for the benefit of trade as part of the common law. Page 303.

Law-merchant; law of merchants:

The rules applicable to commercial paper were transplanted into the common law from the law merchant. They had their origin in the customs and course of business of merchants and bankers, and are now recognized by the courts because they are demanded by the wants and conveniences of the mercantile world. Pages 670-671.

Roman Law:

The common law of England has been largely influenced by the Roman law, in several respects:... Through the development of commercial law. Page 910.

Man's laws, except for many maxims of law, are commercial in nature.

Maxim as found in Bouvier's Law Dictionary, 1856:

An established principle or proposition. A principle of law universally admitted, as being just and consonant with reason.

2. Maxims in law are somewhat like axioms in geometry. 1 Bl. Com. 68. They are principles and authorities, and part of the general customs or common law of the land; and are of the same strength as acts of parliament, when the judges have determined what is a maxim; which belongs to the judges and not the jury. Terms do Ley; Doct. & Stud. Dial. 1, c. 8. Maxims of the law are holden for law, and all other cases that may be applied to them shall be taken for granted. 1 Inst. 11. 67; 4 Rep. See 1 Com. c. 68; Plowd. 27, b.

3. The application of the maxim to the case before the court, is generally the only difficulty. The true method of making the application is to ascertain how the maxim arose, and to consider whether the case to which it is applied is of the same character, or whether it is an exception to an apparently general rule.

4. The alterations of any of the maxims of the common law are dangerous. 2 Inst. 210.

Maxim as found in William C. Anderson's *A Dictionary of Law*, (1893), page 666:

So called...because it's value is the highest and its authority the most reliable, and because it is accepted by all persons at the very highest.

2. The principles and axioms of law, which are general propositions flowing from abstracted reason, and not accommodated to times or men, are wisely deposited in the breasts of the judges to be applied to such facts as come properly before them.

3. When a principle has been so long practiced and so universally acknowledged as to become a maxim, it is obligatory as part of the law.

Maxim of Law as found in Black's Law Dictionary, Third Edition, (1933), page 1171:

An established principle of proposition. A principle of law universally admitted as being a correct statement of the law, or as agreeable to reason. Coke defines a maxim to be "a conclusion of reason" Coke on Littleton, 11a. He says in another place, "A maxim is a proposition to be of all men confessed and granted without proof, argument, or discourse." Coke on Littleton. 67a.

Maxim as found in Black's Law Dictionary, Forth Edition:

Maxims are but attempted general statements of rules of law and are law only to the extent of application in adjudicated cases.

## **Accidents and Injury**

1. An act of God does wrong to no one.
2. The act of God does no injury; that is, no one is responsible for inevitable accidents.
3. No one is held to answer for the effects of a superior force, or of an accident, unless his own fault has contributed.
4. The execution of law does no injury.
5. An action is not given to one who is not injured.
6. An action is not given to him who has received no damages.
7. He who suffers a damage by his own fault, has no right to complain.
8. Mistakes, neglect, or misconducts are not to be regarded as accidents.
9. Whoever pays by mistake what he does not owe, may recover it back; but he who pays, knowing he owes nothing; is presumed to give.
10. What one has paid knowing it not to be due, with the intention of recovering it back, he cannot recover back. [If the IRS accuses you of owing them money, if you want to go to court to dispute it, you must pay them in full what they demand and then sue them to get it back. Which places the burden of proof upon the accused rather than the accuser]
11. **No man ought to be burdened in consequence of another's act.**

12. There may be damage or injury inflicted without any act of injustice.
  13. Not every loss produces an injury.
  14. A personal injury does not receive satisfaction from a future course of proceeding.
  15. Wrong is wiped out by reconciliation.
  16. An injury is extinguished by the forgiveness or reconciliation of the party injured.
- [Luke 17:3-4, 2 Corinthians 2:7-8]

### **Benefits and Privileges**

1. Favors from government often carry with them an enhanced measure of regulation.
2. Any one may renounce a law introduced for his own benefit.
3. No one is obliged to accept a benefit against his consent.
4. He who receives the benefit should also bear the disadvantage.
5. He who derives a benefit from a thing, ought to feel the disadvantages attending it.
6. He who enjoys the benefit, ought also to bear the burden.
7. He who enjoys the advantage of a right takes the accompanying disadvantage.
8. A privilege is, as it were, a private law.
9. A privilege is a personal benefit and dies with the person.
10. One who avails himself of the benefits conferred by statute cannot deny its validity.
11. What I approve I do not reject. I cannot approve and reject at the same time. I cannot take the benefit of an instrument, and at the same time repudiate it.
12. He who does any benefit to another for me is considered as doing it to me.

### **Commerce**

1. Caveat emptor (let the buyer beware).
2. Let the purchaser beware.
3. Let the seller beware.
4. The payment of the price stands in the place of a sale.
5. The payment of the price of a thing is held as a purchase.
6. **Goods are worth as much as they can be sold for.**
7. Mere recommendation of an article does not bind the vendor of it.
8. It is settled that there is to be considered the home of each one of us where he may have his habitation and account-books, and where he has made an establishment of his business.
9. No rule of law protects a buyer who willfully closes his ears to information, or refuses to make inquiry when circumstances of grave suspicion imperatively demand it.
10. Let every one employ himself in what he knows.
11. He at whose risk a thing is done, should receive the profits arising from it.
12. **Usury is odious in law.** [Exodus 22:25, Leviticus 25:36-37, Nehemiah 5:7,10, Proverbs 28:8, Ezekiel 18:8,13,17; 22:12]

## Common Sense

1. When you doubt, do not act.
2. It is a fault to meddle with what does not belong to or does not concern you.
3. Many men know many things, no one knows everything.
4. **One is not present unless he understands.**
5. It avails little to know what ought to be done, if you do not know how it is to be done.
6. He who questions well, learns well.
7. What ever is done in excess is prohibited by law.
8. No one is bound to give information about things he is ignorant of, **but every one is bound to know that which he gives information about.**
9. No man is bound to have foreknowledge of a Divine or a future event.
10. No one is bound to arm his adversary.

## Consent and Contracts

1. Consent makes the law. A contract is a law between the parties, which can acquire force only by consent.
2. Consent makes the law: the terms of a contract, **lawful in its purpose**, constitute the law as between the parties.
3. To him consenting no injury is done.
4. He who consents cannot receive an injury.
5. Consent removes or obviates a mistake.
6. **He who mistakes is not considered as consenting.**
7. Every consent involves a submission; **but a mere submission does not necessarily involve consent.**
8. **A contract founded on a base and unlawful consideration, or against good morals, is null.**
9. One who wills a thing to be or to be done cannot complain of that thing as an injury.
10. The agreement of the parties makes the law of the contract.
11. The contract makes the law.
12. Agreements give the law to the contract.
13. The agreement of the parties overcomes or prevails against the law.
14. **Advice, unless fraudulent, does not create an obligation.**
15. No action arises out of an immoral consideration.
16. **No action arises on an immoral contract.**
17. In the agreements of the contracting parties, **the rule is to regard the intention rather than the words.**
18. The right of survivorship does not exist among merchants for the benefit of commerce.
19. When two persons are liable on a joint obligation, if one makes default the other

must bear the whole.

20. You ought to know with whom you deal.

21. He who contracts, knows, or ought to know, the quality of the person with whom he contracts, otherwise he is not excusable.

22. **He who approves cannot reject.**

23. If anything is due to a corporation, **it is not due to the individual members of it**, nor do the members individually owe what the corporation owes.

24. **Agreement takes the place of the law**: the express understanding of parties supercedes such understanding as the law would imply.

25. Manner and agreement overrule the law.

26. **The essence of a contract being assent, there is no contract where assent is wanting.**

## **Court and Pleas**

1. There can be no plea of that thing of which the dissolution is sought.

2. A false plea is the basest of all things.

3. There can be no plea against an action which entirely destroys the plea.

4. **He who does not deny, admits.** [A well-known rule of pleading]

5. No one is believed in court but upon his oath.

6. An infamous person is repelled or prevented from taking an oath.

7. In law none is credited unless he is sworn. All the facts must, when established by witnesses, be under oath or affirmation.

8. An act of the court shall oppress no one.

9. The practice of a court is the law of the court.

10. There ought to be an end of law suits.

11. It concerns the commonwealth that there be an end of law suits.

12. It is for the public good that there be an end of litigation.

13. A personal action dies with the person. This must be understood of an action for a tort only.

14. **Equity acts upon the person.**

15. No one can sue in the name of another.

## **Court Appearance**

[**This is why we should avoid \*voluntarily\* appearing in court**]

1. **A general appearance cures antecedent irregularity of process, a defective service, etc.**

2. Certain legal consequences are attached to the voluntary act of a person.

3. **The presence of the body cures the error in the name**; the truth of the name cures an error in the description

4. **An error in the name is immaterial if the body is certain.**

5. An error in the name is nothing when there is certainty as to the person.
6. The truth of the demonstration removes the error of the name.

## **Crime and Punishment**

1. A madman is punished by his madness alone.
2. The instigator of a crime is worse than he who perpetrates it.
3. They who consent to an act, and they who do it, shall be visited with equal punishment.
4. Acting and consenting parties are liable to the same punishment.
5. No one is punished for his thoughts.
6. No one is punished for merely thinking of a crime.
7. He who has committed iniquity, shall not have equity.
8. He who is once bad, is presumed to be always so in the same degree.
9. He who is once criminal is presumed to be always criminal in the same kind or way.
10. Whatever is once bad, is presumed to be so always in the same degree.
11. He who does not forbid a crime while he may, sanctions it.
12. He who does not blame, approves.
13. He is clear of blame who knows, but cannot prevent.
14. No one is to be punished for the crime or wrong of another.
15. No guilt attaches to him who is compelled to obey.
16. Gross negligence is held equivalent to intentional wrong.
17. Misconduct binds its own authors. It is a never-failing axiom that everyone is accountable only for his own offence or wrong.
18. In offenses, the will and not the consequences are to be looked to.
19. It is to the intention that all law applies.
20. The intention of the party is the soul of the instrument.
21. Every act is to be estimated by the intention of the doer.
22. An act does not make a man a criminal, unless his intention be criminal.
23. An act does not make a person guilty, unless the intention be also guilty. This maxim applies only to criminal cases; in civil matters it is otherwise.
24. In offenses, the intention is regarded, not the event.
25. The intention amounts to nothing unless some effect follows.
26. Take away the will, and every action will be indifferent.
27. Your motive gives a name to your act.
28. An outlaw is, as it were, put out of the protection of the law.
29. Vainly does he who offends against the law, seek the help of the law.
30. Drunkenness inflames and produces every crime.
31. Drunkenness both aggravates and reveals every crime.
32. He who sins when drunk shall be punished when sober.
33. Punishment is due if the words of an oath be false.
34. A prison is established not for the sake of punishment, but of detention and



guarding.

35. Those sinning secretly are punished more severely than those sinning openly.

36. Punishment ought not to precede a crime.

37. If one falsely accuses another of a crime, the punishment due to that crime should be inflicted upon the perjured informer. [Deuteronomy 19:18]

### **Customs and Usages**

1. Long time and long use, beyond the memory of man, suffices for right.

2. Custom is the best expounder of the law.

3. Custom is another law.

4. A prescriptive and legitimate custom overcomes the law.

5. Custom leads the willing, law compels or draws the unwilling.

6. Usage is the best interpreter of things.

7. Custom is the best interpreter of laws.

8. What is done contrary to the custom of our ancestors, neither pleases nor appears right.

9. Where two rights concur, the more ancient shall be preferred.

### **Expressions and Words**

1. The meaning of words is the spirit of the law. [Romans 8:2]

2. The propriety of words is the safety of property.

3. It is immaterial whether a man gives his assent by words or by acts and deeds.

4. It matters not whether a revocation be by words or by acts.

5. What is expressed renders what is implied silent.

6. An unequivocal statement prevails over an implication.

7. In ambiguous expressions, the intention of the person using them is chiefly to be regarded.

8. **The expression of those things which are tacitly implied operates nothing.**

9. The expression of one thing is the exclusion of another.

10. A general expression is to be construed generally.

11. A general expression implies nothing certain.

12. **General words are understood in a general sense.**

13. When the words and the mind agree, there is no place for interpretation.

14. Every interpretation either declares, extends or restrains.

15. The best interpretation is made from things preceding and following; i.e., the context.

16. Words are to be interpreted according to the subject-matter.

17. He who considers merely the letter of an instrument goes but skin deep into its meaning.

18. Frequently where the propriety of words is attended to, the meaning of truth is lost.

19. Words are to be taken most strongly against him who uses them.
20. Multiplicity and indistinctness produce confusion; and questions, the more simple they are, the more lucid.
21. When two things repugnant to each other are found in a will, the last is to be confirmed.
22. Bad or false grammar does not vitiate a deed or grant.
23. Many things can be implied from a few expressions.
24. Language is the exponent of the intention.
25. Words are indicators of the mind or thought.
26. Speech is the index of the mind. [James 1:26]
27. Laws are imposed, not upon words, but upon things.

### **Fictions**

1. A fiction is a rule of law that assumes something which is or may be false as true.
2. Where truth is, fiction of law does not exist.
3. There is no fiction without law.
4. Fictions arise from the law, and not law from fictions
5. Fiction is against the truth, but it is to have truth.
6. In a fiction of law, equity always subsists.
7. A fiction of law injures no one.
8. Fiction of law is wrongful if it works loss or injury to any one.

### **Fraud and Deceit**

1. It is safer to be deceived than to deceive.
2. A deceiver deals in generals.
3. Fraud lies hid in general expressions.
4. A concealed fault is equal to a deceit.
5. Out of fraud no action arises.
6. A forestaller is an oppressor of the poor, and a public enemy to the whole community and the country.
7. It is a fraud to conceal a fraud.
8. Gross negligence is equivalent to fraud.
9. Once a fraud, always a fraud.
10. What otherwise is good and just, if it be sought by force and fraud, becomes bad and unjust.
11. He is not deceived who knows himself to be deceived.
12. Let him who wishes to be deceived, be deceived.
13. He who does not prevent what he can, seems to commit the thing.
14. He who does not prevent what he can prevent, is viewed as assenting.
15. He who does not forbid what he can forbid, seems to assent.

16. He who does not forbid, when he might forbid, commands.
17. **He who does not repel a wrong when he can, induces it.**
18. Often it is the new road, not the old one, which deceives the traveler.
19. Deceit is an artifice, since it pretends one thing and does another.

## **God and Religion**

1. If ever the law of God and man are at variance, the former are to be obeyed in derogation of the later. [Acts 5:29]
2. That which is against Divine Law is repugnant to society and is void.
3. He who becomes a soldier of Christ has ceased to be a soldier of the world. [2 Timothy 2:3-4]
4. Where the Divinity is insulted the case is unpardonable.
5. Human things never prosper when divine things are neglected.
6. No man is presumed to be forgetful of his eternal welfare, and particularly at the point of death.
7. The church does not die.
8. That is the highest law which favors religion.
9. The law is from everlasting.
10. He who acts badly, hates the light.
11. He who does not willingly speak the truth, is a betrayer of the truth.
12. He who does not speak the truth, is a traitor to the truth.
13. The truth that is not sufficiently defended is frequently overpowered; and he who does not disapprove, approves.
14. **Suppression of the truth is equivalent to the expression of what is false.**
15. Truth, by whomever pronounced, is from God.
16. **Truth fears nothing but concealment.**
17. We can do nothing against truth. [2 Corinthians 13:8]
18. Truth is the mother of justice.
19. To swear is to call God to witness, and is an act of religion.
20. Earlier in time, is stronger in right. First in time, first in right.
21. He who is before in time, is preferred in right.
22. What is first is truest; and what comes first in time, is best in law.
23. No man is ignorant of his eternal welfare.
24. All men know God. [Hebrews 8:11]
25. The cause of the Church is a public cause.
26. The Law of God and the law of the land are all one, and both favor and preserve the common good of the land.
27. No man warring for God should be troubled by secular business.
28. What is given to the church is given to God.

## **Governments and Jurisdiction**

1. That which seems necessary for the king and the state ought not to be said to tend to the prejudice of liberty of the [Christ's] ekklesia.
2. The power which is derived [from God] cannot be greater than that from which it is derived [God]. [Romans 13:1]
3. The order of things is confounded if every one preserves not his jurisdiction [in and of Christ].
4. Jurisdiction is a power introduced for the public good, on account of the necessity of dispensing justice.
5. Every jurisdiction has its own bounds.
6. The government cannot confer a favor which occasions injury and loss to others.
7. A minor ought not to be guardian of a minor, for he is unfit to govern others who does not know how to govern himself.
8. **The government is to be subject to the law, for the law makes government.**
9. **The law is not to be violated by those in government.**

## **Heirs**

1. God, and not man, make the heir. [Romans 8:16]
2. God alone makes the heir, not man.
3. Co-heirs are deemed as one body or person, by reason of the unity of right which they possess. [Romans 8:17, Ephesians 5:31-32]
4. No one can be both owner and heir at the same time.
5. An heir is either by right of property, or right of representation.
6. An heir is the same person with his ancestor. [Because the ancestor, during his life, bears in his body (of law) all his heirs].
7. 'Heir' is a collective name or noun [so it is not private, and has no private rights].
8. Several co-heirs are as one body, by reason of the unity of right which they possess. [Romans 8:17, Ephesians 5:31-32]
9. The law favors a man's inheritance.
10. Heir is a term of law, son one of nature.
11. An heir is another self, and a son is a part of the father.
12. The heir succeeds to the restitution not the penalty.

## **Judges and Judgment**

1. Let justice be done, though the heavens should fall.
2. One who commands lawfully must be obeyed.
3. Whoever does anything by the command of a judge is not reckoned to have done it with an evil intent, because it is necessary to obey. [Isaiah 33:22, "For the LORD is our judge..."]
4. Where a person does an act by command of one exercising judicial authority, the law

will not suppose that he acted from any wrongful or improper motive, because it was his bounden duty to obey.

5. A judgment is always taken as truth.
6. If you judge, understand.
7. It is the duty of a good judge to remove the cause of litigation. [Acts 18:12-16]
8. The end of litigation is justice.
9. To a judge who exceeds his office or jurisdiction no obedience is due.
10. One who exercises jurisdiction out of his territory is not obeyed with impunity.
11. **A twisting of language is unworthy of a judge.**
12. A good judge decides according to justice and right, and prefers equity to strict law.
13. Of the credit and duty of a judge, no question can arise; but it is otherwise respecting his knowledge, whether he be mistaken as to the law or fact.
14. It is punishment enough for a judge that he is responsible to God. [Psalms 2:10-12, Romans 13]
15. **That is the best system of law which confides as little as possible to the discretion of the judge.**
16. That law is the best which leaves the least discretion to the judge; and this is an advantage which results from certainty.
17. He is the best judge who relies as little as possible on his own discretion.
18. **Whenever there is a doubt between liberty and slavery, the decision must be in favor of liberty.**
19. He who decides anything, a party being unheard, though he should decide right, does wrong.
20. He who spares the guilty, punishes the innocent. [Mark 15:6-15, Luke 23:17-25, John 18:38-40]
21. The judge is condemned when a guilty person escapes punishment.
22. What appears not does not exist, and nothing appears judicially before judgment.
23. It is improper to pass an opinion on any part of a sentence, without examining the whole.
24. Hasty justice is the step-mother of misfortune.
25. Faith is the sister of justice.
26. Justice knows not father nor mother; justice looks at truth alone.
27. A judge is not to act upon his personal judgment or from a dictate of private will, but to pronounce according to law and justice.
28. No one should be judge in his own cause.
29. No one can be at once judge and party.
30. A judge is to expound, not to make, the law.
31. It is the duty of a judge to declare the law, not to enact the law or make it.
32. Definite, legal conclusions cannot be arrived at upon hypothetical averments.
33. A judge is the law speaking. [the mouth of the law]
34. A judge should have two salts: the salt of wisdom, lest he be insipid; and the salt of conscience, lest he be devilish.

35. He who flees judgment confesses his guilt.
36. **No man should be condemned unheard.**
37. The judge is counsel for the prisoner.
38. Everyone is presumed to be innocent until his guilt is established beyond a reasonable doubt.
39. Justice is neither to be denied nor delayed.
40. It is the property of a Judge to administer justice, not to give it.
41. Justice is an excellent virtue, and pleasing to the Most High.

## Law

1. A maxim is so called because its dignity is chiefest, and its authority most certain, and because universally approved of all.
2. All law has either been derived from the consent of the people, established by necessity, confirmed by custom, or of Divine Providence.
3. Nothing is so becoming to authority [God] as to live according to the law [of God].
4. He acts prudently who obeys the commands of the Law. [Ecclesiastes 12:13]
5. Law is the safest helmet; under the shield of the law no one is deceived. [Ephesians 6:13-17, 1 Thessalonians 5:8]
6. An argument drawn from authority [scripture] is the strongest in law.
7. An argument drawn from a similar case, or analogy, avails in law.
8. That which was originally void, does not by lapse of time become valid.
9. The law does not seek to compel a man to do that which he cannot possibly perform.
10. **The law requires nothing impossible.**
11. **The law compels no one to do anything which is useless or impossible.**

3. **Names of things ought to be understood according to common usage, not according to the opinions of individuals.**
4. **A name is not sufficient if a thing or subject for it does not exist by law or by fact.**
5. Not to believe rashly is the nerve of wisdom.
6. **Reason is a ray of the Divine Light.** [Isaiah 1:18]
7. Abundant caution does no harm.
8. **External acts indicate undisclosed thoughts.**
9. **External actions show internal secrets.**
10. **Outward acts evince the inward purpose.**
11. **You will perceive many things more easily by practice than by rules.**
12. Remove the cause and the effect will cease.

### **Witnesses and Proof**

1. A witness is a person who is present at and observes a transaction. [**The government only has over persons, not substance. Any video tape, audio tape, computer printout, etc. that are used as witnesses.**]
2. **The answer of one witness shall not be heard.** [Deuteronomy 19:15]
3. **The testimony of one witness, unsupported, may not be enough to convict; for there may then be merely oath against oath.**
4. **This is a maxim of the civil law, where everything must be proved by two witnesses.** [Matthew 18:16, 2 Corinthians 13:1]

5. In law, none is credited unless he is sworn. All facts must, when established by witnesses, be under oath or affirmation.
6. A confession made in court is of greater effect than any proof.
7. No man is bound to produce writings against himself.
8. No one can be made to testify against himself or betray himself.
9. No one is bound to accuse himself.
10. No one ought to accuse himself, unless before God.
11. One making a voluntary confession, is to be dealt with more mercifully.
12. He ought not to be heard who advances a proposition contrary to the rules of law.
13. False in one (particular), false in all.
14. Deliberate falsehood in one matter will be imputed to related matters.
15. He who alleges contradictory things is not to be listened to.
